# **Grievance 49**

January 1, 2019

**New California is a new state in development exercising its Constitutional Right to form from the State of California. The process to form New California is authorized and codified in Article IV Sections 3 & 4 of the United States Constitution.**

### **Statement of Intent**

The Citizens of New California have decided to remedy the abuse of power by the government of California by exercising their right to form a new state provided in United States Constitution Article IV Sections 3 and Section 4.

***“We are determined to live under a State Government in the United States of America and under the Constitution of the United States.”***

### **New California Declaration of Independence of January 15, 2018 states:**

***“Whenever any Form of Government becomes destructive it is the Right of the People to alter or to abolish it, and to institute new Government.***

***When a long train of abuses and acts to seize and hold the people’s power without legal authority and pursuing invariably the same Object that clearly demonstrates a design to reduce them under absolute Despotism, it is their right,***

**Preamble of the New California State Constitution states:**

*We, the representatives of the undersigned Counties within the State of California, do acknowledge and humbly invoke the favor of Almighty God for continued civil and religious liberty to ourselves and our posterity....*

**First Amendment of the United States Constitution states:**

***"Congress shall make no law respecting an establishment of religion, or prohibiting the free exercise thereof; or abridging the freedom of speech, or of the press; or the right of the people peaceably to assemble, and to petition the government for a redress of grievances."***

## **Declaration of Grievance**

### **Statement of Facts**

The people of California are suffering from a tyrannical state government which fails to provide a republican form of governance, enables and supports across its southern border the invasion of the United States of America by illegal foreign nationals and protects vicious criminals who commit outrageous acts of violence upon the Citizens of America all caused by a government of and for a monopoly system lead by a tyrannical dictator who openly defies federal law.

**California State Government is in Direct Violation of the Following:**

#### **United States Constitution Article IV Section 4**

***"The United States shall guarantee to every state in this union a republican form of government, and shall protect each of them against invasion; and on application of the legislature, or of the executive (when the legislature cannot be convened) against domestic violence."***

#### **United States Constitution Article VI Section 2**

***This Constitution, and the Laws of the United States which shall be made in Pursuance thereof; and all Treaties made, or which shall be made, under the Authority of the United States, shall be the supreme Law of the Land; and the Judges in every State shall be bound thereby, any Thing in the Constitution or Laws of any State to the Contrary notwithstanding.***

## MASS “LAWLESSNESS” IS NOW THE ORDER OF THE DAY

California’s tyrannical governor the mono-party government along with their associates at the county and city levels are engaging in mass “lawlessness”. California is the most lawless and tyrannical government of any state in the Union of States and denies U.S. Citizens their Constitutional Rights under Article IV, Section 4 and Article VI, Section 2 of the U.S. Constitution.

**Article IV, Section 4** is known as the “Guarantee Clause” of the U.S. Constitution. The State and Federal Governments MUST provide to the Citizens of the United States the three elements of Article IV, Section 4.

**Republican form of government:** California is a failed state and no longer provides to its citizens a representative government. California has a “mono” party system in which there is no bi-cameral legislature lead by a dictator as governor. Failure has not occurred due to external causes, but rather as a result of the runaway tyranny that is the California government. It is evident for all to see that these failures to govern are by a design that evinces to replace our very form of constitutional government with a neo-communist state governed by the tenets of unaccountable and dictatorial globalism.

**Protect each of them against invasion:** California is the national leader if not the world in encouraging and financing the illegal foreign national invasion of the southern border of California. In 2017 California spent \$27 billion on illegal foreign nationals who came into the United States. These illegal foreign nationals were then granted rights and privileges reserved for American Citizens. A security vacuum at the border has been created and is being filled by forces hostile to the United States of America.

**Protection against domestic violence:** The Citizens of California are daily put at risk of their safety, happiness, security and livelihood by the damage the rogue government of California has perpetrated on the territorial integrity of the California and United States border thus threatening the Union of the United States of America.

**Article VI, Section 2** Supremacy Clause is the Article in the U.S. Constitution that binds the Union of States together.
