New California is a new state in development exercising its Constitutional Right to form from the State of California. The process to form New California is authorized and codified in Article IV Sections 3 & 4 of the United States Constitution.

Statement of Intent

The Citizens of New California have decided to remedy the abuse of power by the government of California by exercising their right to form a new state provided in United States Constitution Article IV Sections 3 and Section 4.

“We are determined to live under a State Government in the United States of America and under the Constitution of the United States.”

New California Declaration of Independence of January 15, 2018 states:

“Whenever any Form of Government becomes destructive it is the Right of the People to alter or to abolish it, and to institute new Government.

When a long train of abuses and acts to seize and hold the people’s power without legal authority and pursuing invariably the same Object that clearly demonstrates a design to reduce them under absolute Despotism, it is their right,

it is their duty, to throw off such Government, and to provide new Guards for their future security.

Preamble of the New California State Constitution states:

We, the representatives of the undersigned Counties within the State of California, do acknowledge and humbly invoke the favor of Almighty God for continued civil and religious liberty to ourselves and our posterity....

First Amendment of the United States Constitution states:

"Congress shall make no law respecting an establishment of religion, or prohibiting the free exercise thereof; or abridging the freedom of speech, or of the press; or the right of the people peaceably to assemble, and to petition the government for a redress of grievances."

Declaration of Grievance

Statement of Facts

The people of California are suffering from a tyrannical state government which fails to provide a republican form of governance, enables and supports across its southern border the invasion of the United States of America by illegal foreign nationals and protects vicious criminals who commit outrageous acts of violence upon the Citizens of America all caused by a government of and for a mono-party system lead by a tyrannical dictator who openly defies federal law.

California State Government is in Direct Violation of the Following:

United States Constitution Article IV Section 4

"The United States shall guarantee to every state in this union a republican form of government, and shall protect each of them against invasion; and on application of the legislature, or of the executive (when the legislature cannot be convened) against domestic violence."

United States Constitution Article VI Section 2

This Constitution, and the Laws of the United States which shall be made in Pursuance thereof; and all Treaties made, or which shall be made, under the Authority of the United States, shall be the supreme Law of the Land; and the Judges in every State shall be bound thereby, any Thing in the Constitution or Laws of any State to the Contrary notwithstanding.

ELIMINATION OF COUNTY SHERIFFS IS THE ORDER OF THE DAY

The California socialist governor the socialist mono party government along their socialist associates at the county and city levels are engaging in elimination of the county Sheriff in the rural counties of California known as New California State.

In the [United States](#), the [sheriff](#) is the “official” in a [county](#) or [independent city](#) responsible for [keeping the peace](#) and [enforcing the law](#). Unlike most officials in [law enforcement in the United States](#), sheriffs are usually [elected](#). Elected sheriffs are accountable directly to the [constitution of their state](#), the [United States Constitution](#), [statutes](#), and the citizens of their county.

The current socialist governor and socialist mono party government along with local socialists officials are seeking the elimination of the county Sheriff. Their efforts to do so are actively underway in the halls of the state capital with the support of their globalist “partners”.

Since the mid 1990s the socialists in California working alongside their criminal cartel partners have already eliminated 2 vital law enforcement agencies.

The **California State Police** was a state police agency founded in 1887 which primarily served to protect the [State Capitol Building](#), the [Governor](#), other state agencies. They provided [police](#) services to all state agencies that did not have their own police force they help to protect the southern border. They were eliminated in 1995. Elimination of the State Police has opened the southern border to the invasion by illegal foreign nationals we see today.

The **California Bureau of Narcotic Enforcement** (BNE) was a drug law enforcement agency, under the [California Department of Justice](#) (CA DOJ). The BNE was established in 1927, and was the oldest [narcotic enforcement bureau](#) in the United States at the time of it disbanding. The BNE was eliminated in 2011 by the socialist governor and the socialist attorney general thus opening the state to criminal cartel invasion which has raped the environment and led to wide spread criminal activity in the state.

Bernadine Smith writes in [“THE SHERIFF: A NECESSARY OFFICE”](#)

“Already laid over the nation is a militarized infrastructure: the Homeland Security Agency. It is the foundation upon which a worldwide regional system of total command and control can be applied to operate what was once meant to be a republic. Very little will be left to local autonomy. This is a violation of the principles of the Constitution: the Supreme Law of the Land. The ridiculous excuse for this installation is that we may have to give up some of our rights for safety and security. *What it is really saying is that we must co-operate in the overthrow of our own government in order to provide protection for ourselves and our government!* It does not make sense!

The county sheriff is being introduced to a maneuver that will gradually eliminate him by a merger with federal marshals. Already under threat by an Advisory groups. the traditional American constitutional sheriff will be divested of his authority. He will lose his control over the jails and the courts, and all civilian law enforcement will be consolidated on the federal regional government level.

The first intent is to demote the sheriff and his deputies down to the functions of a beat officer where they can be managed by the Homeland Security Agency as a non-elective county police system.

If the sheriff disappears, good citizens will lose the only opportunity they have to vote for a representative in law enforcement of their own choosing who is endowed with special powers to deal with special crimes. The assault on the sheriff had its beginning as far back as the Wickersham Report, done under Herbert Hoover's administration".

Insurrection

The government of California, the current governor and mono-party system along with local officials are following a coordinated design with the intent to actively engage in *acts of insurrection* against the U.S. Constitution.

The **Insurrection Act of 1807** is a [United States federal law](#) that governs the ability of the [President of the United States](#) to deploy [military troops](#) within the [United States](#) to put down lawlessness [insurrection](#), and [rebellion](#).
