New California is a new state in development exercising its Constitutional Right to form from the State of California. The process to form New California is authorized and codified in Article IV Sections 3 & 4 of the United States Constitution.

Statement of Intent

The Citizens of New California have decided to remedy the abuse of power by the government of California by exercising their right to form a new state provided in United States Constitution Article IV Sections 3 and Section 4.

“We are determined to live under a State Government in the United States of America and under the Constitution of the United States.”

**New California Declaration of Independence of
January 15, 2018 states:**

“Whenever any Form of Government becomes destructive it is the Right of the People to alter or to abolish it, and to institute new Government.

When a long train of abuses and acts to seize and hold the people’s power without legal authority and pursuing invariably the same Object that clearly demonstrates a design to reduce them under absolute Despotism, it is their right, it

Preamble of the New California State Constitution states:

We, the representatives of the undersigned Counties within the State of California, do acknowledge and humbly invoke the favor of Almighty God for continued civil and religious liberty to ourselves and our posterity....

First Amendment of the United States Constitution states:

"Congress shall make no law respecting an establishment of religion, or prohibiting the free exercise thereof; or abridging the freedom of speech, or of the press; or the right of the people peaceably to assemble, and to petition the government for a redress of grievances."

Declaration of Grievance

Statement of Facts

The people of California are suffering from a tyrannical state government which fails to provide a republican form of governance, enables and supports across its southern border the invasion of the United States of America by illegal foreign nationals and protects vicious criminals who commit outrageous acts of violence upon the Citizens of America all caused by a government of and for a mono-party system lead by a tyrannical dictator who openly defies federal law.

California State Government is in Direct Violation of the Following:

United States Constitution Article IV Section 4

"The United States shall guarantee to every state in this union a republican form of government, and shall protect each of them against invasion; and on application of the legislature, or of the executive (when the legislature cannot be convened) against domestic violence."

United States Constitution Article VI Section 2

This Constitution, and the Laws of the United States which shall be made in Pursuance thereof; and all Treaties made, or which shall be made, under the Authority of the United States, shall be the supreme Law of the Land; and the Judges in every State shall be bound thereby, any Thing in the Constitution or Laws of any State to the Contrary notwithstanding.

The California socialist governor the socialist mono party government along with socialist county, city officials and “Party” apparatchiks are now setting the stage to take advantage of the federal government’s disaster relief money pot.

Its no secrete the state of California government is in a financial meltdown just the loss of projected taxes for the months of December 2018, January and February of 2019 amount to over \$19 billion. As the water level has risen in the reservoir leaks are visible on the face of the main spillway in the exact same spot where the 2017 spillway ruptured. The adjacent dirt abutments are leaking as well as the emergency spillway in front of the o.g. weir.

On cue “nature” has provided over 160 percent of snow and rain and the Oroville reservoir is approaching maximum capacity. Since the 2017 dam failure the cost to repair the dam has exceeded \$1.1 billion dollars. Unfortunately, the repairs which have been so costly are now proven to be a failure.

The world of dam safety has the highest regard for experts such as Scott Cahill and Dr. Robert Bea from the University of California, Berkley both of

whom have been critical of the repairs by the California Department of Water Resources.

Dr. Bea, a co-author of a report warning of a green spot near the Oroville Dam in July 2017 is a professor emeritus of engineering at Berkeley called the complete repair of the Oroville dam spillway is nothing more than a “Patch and pray operation”.

Its obvious we all need prayer as the “patches” are not holding. For California state socialist and their apparatchiks a possible disaster at the Oroville dam would a cash cow without the farts.
