New California is a new state in development exercising its Constitutional Right to form from the State of California. The process to form New California is authorized and codified in Article IV Sections 3 & 4 of the United States Constitution.

Statement of Intent

The Citizens of New California have decided to remedy the abuse of power by the government of California by exercising their right to form a new state provided in United States Constitution Article IV Sections 3 and Section 4.

“We are determined to live under a State Government in the United States of America and under the Constitution of the United States.”

**New California Declaration of Independence of
January 15, 2018 states:**

“Whenever any Form of Government becomes destructive it is the Right of the People to alter or to abolish it, and to institute new Government.

When a long train of abuses and acts to seize and hold the people’s power without legal authority and pursuing invariably the same Object that clearly demonstrates a design to reduce them under absolute Despotism, it is their right, it

is their duty, to throw off such Government, and to provide new Guards for their future security.

Preamble of the New California State Constitution states:

We, the representatives of the undersigned Counties within the State of California, do acknowledge and humbly invoke the favor of Almighty God for continued civil and religious liberty to ourselves and our posterity....

First Amendment of the United States Constitution states:

"Congress shall make no law respecting an establishment of religion, or prohibiting the free exercise thereof; or abridging the freedom of speech, or of the press; or the right of the people peaceably to assemble, and to petition the government for a redress of grievances."

Declaration of Grievance

Statement of Facts

The people of California are suffering from a tyrannical state government which fails to provide a republican form of governance, enables and supports across its southern border the invasion of the United States of America by illegal foreign nationals and protects vicious criminals who commit outrageous acts of violence upon the Citizens of America all caused by a government of and for a mono-party system lead by a tyrannical dictator who openly defies federal law.

California State Government is in Direct Violation of the Following:

United States Constitution Article IV Section 4

"The United States shall guarantee to every state in this union a republican form of government, and shall protect each of them against invasion; and on application of the legislature, or of the executive (when the legislature cannot be convened) against domestic violence."

United States Constitution Article VI Section 2

This Constitution, and the Laws of the United States which shall be made in Pursuance thereof; and all Treaties made, or which shall be made, under the Authority of the United States, shall be the supreme Law of the Land; and the Judges in every State shall be bound thereby, any Thing in the Constitution or Laws of any State to the Contrary notwithstanding.

LOCAL COMMUNITIES AND CARTELS ARE THE ORDER OF THE DAY
The California socialist governor, the socialist mono party government along with socialist county, city officials and "Party" apparatchiks are now setting the stage to

destroy the lives of millions of children of United States Citizens living in California through “cartel” marijuana sales.

California's socialist treasurer is lobbying the mono party legislature to slash recreational pot taxes by 30 percent after legalized sales fall \$1 billion short of budgeted tax revenue.

California tax collection is being hammered, with the [state controller reporting](#) a \$4.8-billion revenue miss in December, PG&E bankruptcy potentially wiping out \$5 billion in taxes, and the treasurer warning that recreational marijuana taxes could fall \$1 billion short.

The socialist treasurer and legislators have introduced *"Temporary Cannabis Tax Reduction"* (A.B. 286) to *"reduce California's cannabis excise tax from 15 percent to 11 percent and suspend the cultivation tax altogether through 2022."*

California voters passed a medical marijuana initiative in 1996 that allowed regulated sales at state-licensed health dispensaries. But advocates put Proposition 64, the "Control, Regulate and Tax Adult Use of Marijuana Act," on the 2016 ballot based on projections that legal recreation sales would generate 1,435 and 1,824 tons of pot demand, produce \$15.9 to \$20.2 billion in sales, and generate \$2.4 to \$3 billion in new state taxes.

Legal marijuana sales were projected to hit \$4 billion in its 2018 launch year, pass the \$5 billion level for statewide beer sales in 2019, and continue to rise as state law enforcement pushed the vast majority of pot sales into legally licensed dispensaries.

The projections assumed that recreational consumers would be willing to pay about \$15.40 per gram from a state licensed dispensary versus the illegal cartel "black market" rate of \$7.33 a gram. Advocates claimed that about \$1.3 billion of legal California sales would come from marijuana tourists flying in from states where pot is still illegal.

The expected surge in demand for legal sales of recreational marijuana was [projected to support](#) between \$8.37 billion and \$10.64 billion of total industry activity. That figure included between 81,141 and 103,145 new jobs generating \$3.57 and 4.52 billion in additional California labor income. *This was a big lie.*

But the [California Department of Tax and Fee Administration reported](#) in November that cannabis tax revenue for the third quarter of 2018 was only \$93.1 million, including \$52.4 million in excise tax, \$12 million in cultivation taxes, and \$28.7 million in sales tax revenue. With sales up only 15 percent from the prior quarter, tax collection came in \$101 million lower than projections that had already been ratcheted down three times.

The pot sales shortfall is hammering cities like Santa Rosa that [tacked on](#) an 8-percent local sales tax and a \$25-a-foot dispensary zoning fee. Santa Rosa marijuana tax collection came in at just \$468,000 versus a budgeted revenue of \$2.5 million.

[The socialist treasurer pleaded](#) for marijuana tax relief: *"This is anywhere from a \$6 billion to a \$20 billion industry in California. So we want to help them ... get into the regulated market and come in from the 'black market.'"*

Seeing a bonanza in taxes socialist communities are now working alongside cartels that deal in black market drugs, marijuana, child prostitution, sex trafficking and the trafficking in human flesh into slavery to pursue tax revenue that will destroy the lives of the people and communities they serve.

Insurrection

The government of California, the current governor and mono-party system along with local officials are following a coordinated design with the intent to actively engage in ***acts of insurrection*** against the U.S. Constitution.

The **Insurrection Act of 1807** is a [United States federal law](#) that governs the ability of the [President of the United States](#) to deploy [military troops](#) within the [United States](#) to put down lawlessness [insurrection](#), and [rebellion](#).
