New California is a new state in development exercising its Constitutional Right to form from the State of California. The process to form New California is authorized and codified in Article IV Sections 3 & 4 of the United States Constitution.

Statement of Intent

The Citizens of New California have decided to remedy the abuse of power by the government of California by exercising their right to form a new state provided in United States Constitution Article IV Sections 3 and Section 4.

“We are determined to live under a State Government in the United States of America and under the Constitution of the United States.”

New California Declaration of Independence of

January 15, 2018 states:

“Whenever any Form of Government becomes destructive it is the Right of the People to alter or to abolish it, and to institute new Government.

When a long train of abuses and acts to seize and hold the people’s power without legal authority and pursuing invariably the same Object that clearly demonstrates a design to reduce them under absolute Despotism, it is their Right, it is their Duty, to throw off such Government, and to provide new Guards for their future security.

Preamble of the New California State Constitution states:

We, the representatives of the undersigned Counties within the State of California, do acknowledge and humbly invoke the favor of Almighty God for continued civil and religious liberty to ourselves and our posterity....

First Amendment of the United States Constitution states:

"Congress shall make no law respecting an establishment of religion, or prohibiting the free exercise thereof; or abridging the freedom of speech, or of the press; or the right of the people peaceably to assemble, and to petition the government for a redress of grievances."

Fourth Amendment of the United States Constitution states:

The right of the people to be secure in their persons, houses, papers, and effects, against unreasonable searches and seizures, shall not be violated, and no warrants shall issue, but upon probable cause, supported by oath or affirmation, and particularly describing the place to be searched, and the persons or things to be seized.

The Counties of New California State brought forward 95 Chapter I Grievances between January 2018 and November 2019. On April 28, 2020 New California State will issue 95 additional Chapter II Grievances to be announced in public on Tuesdays at 11:00 am.

Declaration of Grievance Statement of Facts

The people of California are suffering from a tyrannical state government which fails to provide a republican form of governance, enables and supports across its southern border the invasion of the United States of America by illegal foreign nationals and protects vicious criminals who commit outrageous acts of violence upon the Citizens of America all caused by a government of and for a mono-party system lead by a tyrannical dictator who openly defies federal law.

California State Government Violates the Following: United States Constitution Article IV Section 4

"The United States shall guarantee to every state in this union a republican form of government, and shall protect each of them against invasion; and on application of the legislature, or of the executive (when the legislature cannot be convened) against domestic violence."

United States Constitution Article VI

This Constitution, and the Laws of the United States which shall be made in Pursuance thereof; and all Treaties made, or which shall be made, under the Authority of the United States, shall be the supreme Law of the Land; and the Judges in every State shall be bound thereby, any Thing in the Constitution or Laws of any State to the Contrary notwithstanding.

First Amendment, United States Constitution

"Congress shall make no law respecting an establishment of religion, or prohibiting the free exercise thereof; or abridging the freedom of speech, or of the press; or the right of the people peaceably to assemble, and to petition the government for a redress of grievances."

Fourteenth Amendment, United States Constitution

Section 1. *All persons born or naturalized in the United States, and subject to the jurisdiction thereof, are citizens of the United States and of the State wherein they reside. No State shall make or enforce any law which shall abridge the privileges or immunities of citizens of the United States; nor shall any State deprive any person of life, liberty, or property, without due process of law; nor deny to any person within its jurisdiction the equal protection of the laws.*

Section 3. *No Person shall be a Senator or Representative in Congress, or elector of President and Vice-President, or hold any office, civil or military, under the United States, or under any State, who, having previously taken an oath, as a member of Congress, or as an officer of the United States, or as a member of any State legislature, or as an executive or judicial officer of any State, to support the Constitution of the United States, shall have engaged in insurrection or rebellion against the same, or given aid or comfort to the enemies thereof. But Congress may by a vote of two-thirds of each House, remove such disability.*

ORDER OF THE DAY THE CONSTITUTION KNOWS NO CURFEW

We, the People, of the Unified Counties of New California seek the removal of the California state GOVERNOR. *We* are determined to stop the “one man rule” of a *pusillanimous* craven dictator whose words and actions are a grave danger to all U.S. Citizens living in California.

THE DICTATOR ISSUES A CURFEW DESIGNED TO DEPRIVE THE PEOPLE OF THEIR LIBERTY

AND TO ASSIST IN THE INSURRECTION AGAINST THE UNITED STATES OF AMERICA AND ITS CITIZENS RESIDING IN CALIFORNIA!

As if all the other grabs at power weren't enough to enrage the citizens of this state, now the dictator, Gavin Newsom is demanding a curfew to stop the spread of the virus or to “flatten the curve” as we were first told was the justification for police state measures that the people would never consider tolerating under ordinary circumstances. This is just naked tyranny and dictatorship by a pusillanimous, controlling dictator who is becoming increasingly dangerous and desperate in his drive to control the people.

This curfew is being demanded as a solution to a non-existent problem. The people are not out en masse spreading the virus in the middle of the night!

It is becoming very clear that the dictator has other reasons for the imposition of a curfew. Curfews have been used by dictators and tyrants to prevent revolution, to deprive the people of the ability to organize, to deprive the people of the ability to freely travel and to deprive the people of conducting any activity at all that would threaten the dictatorship. Curfews have also, traditionally been used by communist dictators to create conditions whereby they could arrest and disappear dissenters and

other political enemies in the middle of the night and avoid the public eye. What does this nefarious dictator intend to use this curfew for, since its effect in stopping the spread of this or any virus is barely worth considering? Human contact occurs during the day time, not in the middle of the night? We reject the explanation by the dictator for his demand that we be subject to this or any curfew.

Curfews are generally and historically associated with direct control of the population by the police or the military, the suspension of civil law and normal civil functions. The imposition of curfews, historically precedes the imposition of martial law.

What liberty that has not been stolen from the people through fraudulent elections is now being stolen through expanded authoritarian overreach and dictatorial power.

We, the People have every expectation that this curfew will enable the free movement at night of the Governor's terrorist allies – ANTIFA, BLM, THE CARTELS AND OTHER FOREIGN ENEMIES ON AMERICAN SOIL to conduct warfare and terrorism against the populace and to assist in an insurrection.

While the people are disallowed from celebrating holidays, attending normal church services, conducting funerals, and eating at restaurants, the terrorists are not hindered in the slightest by the Governor from conducting their treasonous and hostile activities. The dictatorial and traitorous governor, Gavin Newsom has already demonstrated through his actions that he will not apply the same laws to these terrorists that he applies to We, the People. He is providing aid and comfort to enemies of the United States of America.

He is demonstrating his participation in an insurrection against the United States of America under the guise of fighting a virus that has a survival rate greater than 99% and We the People are wise to his activities and his intentions. He is intent on remaining in power by force and in collaborating with foreign and domestic enemies in the process and depriving the citizens of rights they possess by law.

We request the **President of the United States** act immediately to remedy these abuses by the California state and "Declare a State of Insurrection" exists in California.

Insurrection
