Chapter II

Grievance 6

June 2, 2020

New California is a new state in development exercising its Constitutional Right to form from the State of California. The process to form New California is authorized and codified in Article IV Sections 3 & 4 of the United States Constitution.

Statement of Intent

The Citizens of New California have decided to remedy the abuse of power by the government of California by exercising their right to form a new state provided in United States Constitution Article IV Sections 3 and Section 4.

“We are determined to live under a State Government in the United States of America and under the Constitution of the United States.”

New California Declaration of Independence of

January 15, 2018 states:

“Whenever any Form of Government becomes destructive it is the Right of the People to alter or to abolish it, and to institute new Government.

When a long train of abuses and acts to seize and hold the people’s power without legal authority and pursuing invariably the same Object that clearly demonstrates a design to reduce them under absolute Despotism, it is their Right, it is their Duty, to throw off such Government, and to provide new Guards for their future security.

Preamble of the New California State Constitution states:

We, the representatives of the undersigned Counties within the State of California, do acknowledge and humbly invoke the favor of Almighty God for continued civil and religious liberty to ourselves and our posterity....

First Amendment of the United States Constitution states:

"Congress shall make no law respecting an establishment of religion, or prohibiting the free exercise thereof; or abridging the freedom of speech, or of the press; or the right of the people peaceably to assemble, and to petition the government for a redress of grievances."

Fourth Amendment of the United States Constitution states:

The right of the people to be secure in their persons, houses, papers, and effects, against unreasonable searches and seizures, shall not be violated, and no warrants shall issue, but upon probable cause, supported by oath or affirmation, and particularly describing the place to be searched, and the persons or things to be seized.

The Counties of New California State brought forward 95 Chapter I Grievances between January 2018 and November 2019. On April 28, 2020 New California State will issue 95 additional Chapter II Grievances to be announced in public on Tuesdays at 11:00 am.

Declaration of Grievance

Statement of Facts

The people of California are suffering from a tyrannical state government which fails to provide a republican form of governance, enables and supports across its southern border the invasion of the United States of America by illegal foreign nationals and protects vicious criminals who commit outrageous acts of violence upon the Citizens of America all caused by a government of and for a mono-party system lead by a tyrannical dictator who openly defies federal law.

California State Government is in Direct Violation of the Following:

United States Constitution Article IV Section 4

"The United States shall guarantee to every state in this union a republican form of government, and shall protect each of them against invasion; and on application of the legislature, or of the executive (when the legislature cannot be convened) against domestic violence."

United States Constitution Article VI

This Constitution, and the Laws of the United States which shall be made in Pursuance thereof; and all Treaties made, or which shall be made, under the Authority of the United States, shall be the supreme Law of the Land; and the Judges in every State shall be bound thereby, any Thing in the Constitution or Laws of any State to the Contrary notwithstanding.

Fourth Amendment of the United States Constitution

The right of the people to be secure in their persons, houses, papers, and effects, against unreasonable searches and seizures, shall not be violated, and no warrants shall issue, but upon probable cause, supported by oath or affirmation, and particularly describing the place to be searched, and the persons or things to be seized.

REVOLUTION AND BETRAYAL

INSURRECTION AND REBELLION

The citizens of New California are under ACTIVE siege by DESIGNATED terrorist groups from within our borders and also by DESIGNATED terrorist groups and foreign nationals crossing state lines with weapons, with intent to overthrow the United States of America, and using our state to establish a "beachhead" for a revolution to overthrow the United States of America from our own soil.

The history of the acting governor of California is a history characterized by betrayal, treasonous relationships with foreign agents, and the shirking of his responsibility as the Commander of the California National Guard troops that he has at his disposal to provide for the security of the People and to assure domestic tranquility. Rather than functioning with fidelity to his Oath of Office, **he, in the most cowardly and treacherous manner, is using the troops at his disposal to provide security for the looters, vandals, and would-be murderers that pose a clear and imminent danger to our lives and safety. This governor has associated himself with known designated terrorists and has become an active participant in the effort to overthrow this state and this nation.**

While the first amendment of the United States Constitution codifies the right of the people to peaceably assemble, it does NOT codify a right to riot, loot, commit arson, and vandalize. In the face of riots, murder, vandalism, arson, and other outrageous acts, the mono-party government and all its establishment, from **the Governor** all the way down to the level of the **"sanctuary city" governments, have actively demonstrated a unified refusal to enforce the law and a unified, pre-meditated refusal to arrest violent criminals associated with ongoing riots and TERRORIST ACTS now emerging in California.**

The President of the United States has now signed the Insurrection Act of 1807 which governs the ability of the President of the United States to deploy military troops within the United States to suppress civil disorder, insurrection, and rebellion. Combined with the International Economic Emergency Powers Act which was signed in effect in March 2020 by the President to combat the Covid-19 threat the President now has complete control to act to protect all Citizens in all states with all means necessary superseding the governor's authorities and powers to stop rioting, violence, looting, mayhem and terrorist attacks with thousands and thousands U.S. troops and law enforcement officers.

The days have grown long since the current governor of California declared he would implement the use of the California National Guard yet the National Guard has not been deployed and the rioting, violence, looting, mayhem and terrorist attacks continue at an accelerated rate as the perpetrators act with impunity.

Its abundantly clear the governor is deliberately failing to deploy the California National Guard over the state and failing to order them to stop the terrorist activities. This is the governor's admission to the world of his own treason to the very people he has sworn an oath to protect and defend.

The circumstances that the citizens of this state have endured since before our process of redressing the government with petitions of our grievances have also necessitated the formation of a government that has sworn allegiance to our nation, the United States of America, and now these circumstances have necessitated the formation of a New California State Militia to fill the void left by the lack of deployment of the California National Guard.

It is our **“Right it is our Duty”** to protect our Declaration of Independence, our Constitution and our Bill of Rights with all means necessary including the Right to take up arms and utilize the 2nd Amendment Rights.

We request an audience with the President and the Congress of these United States to assert our plight and consider the remedy to these abuses by the establishment of the New California State.

Insurrection

The government of California, the current socialist governor and mono-party system along with local officials are following a coordinated design with the intent to actively engage in **acts of insurrection** against the U.S. Constitution.

The **Insurrection Act of 1807** and the **Emergency Economic Powers Act** are United States federal laws that govern the ability of the President of the United States to deploy military troops within the United States to put down lawlessness insurrection, and rebellion.

Acts of Secession

Therefore the California government in conjunction with the socialist state executive, instituted wherever the current socialist governor has usurped power has created a reign of terror on United States Citizens living in California with the intent to **secede** from the United States of America and thus destroy the very **Union of States** which secures our **Liberty and Freedom**.

Abdication of Authority

Betrayal by the sitting socialist governor of California the mono-party legislature and local elected officials is evidence of **abdication** of their **responsibilities** of **authority** and **sovereignty** over the State and Citizens of the United States living in California.
