Chapter II

Grievance 11

July 7, 2020

New California is a new state in development exercising its Constitutional Right to form from the State of California. The process to form New California is authorized and codified in Article IV Sections 3 & 4 of the United States Constitution.

Statement of Intent

The Citizens of New California have decided to remedy the abuse of power by the government of California by exercising their right to form a new state provided in United States Constitution Article IV Sections 3 and Section 4.

“We are determined to live under a State Government in the United States of America and under the Constitution of the United States.”

New California Declaration of Independence of

January 15, 2018 states:

“Whenever any Form of Government becomes destructive it is the Right of the People to alter or to abolish it, and to institute new Government.

When a long train of abuses and acts to seize and hold the people’s power without legal authority and pursuing invariably the same Object that clearly demonstrates a design to reduce them under absolute Despotism, it is their Right, it is their Duty, to throw off such Government, and to provide new Guards for their future security.

Preamble of the New California State Constitution states:

We, the representatives of the undersigned Counties within the State of California, do acknowledge and humbly invoke the favor of Almighty God for continued civil and religious liberty to ourselves and our posterity....

First Amendment of the United States Constitution states:

"Congress shall make no law respecting an establishment of religion, or prohibiting the free exercise thereof; or abridging the freedom of speech, or of the press; or the right of the people peaceably to assemble, and to petition the government for a redress of grievances."

Fourth Amendment of the United States Constitution states:

The right of the people to be secure in their persons, houses, papers, and effects, against unreasonable searches and seizures, shall not be violated, and no warrants shall issue, but upon probable cause, supported by oath or affirmation, and particularly describing the place to be searched, and the persons or things to be seized.

The Counties of New California State brought forward 95 Chapter I Grievances between January 2018 and November 2019. On April 28, 2020 New California State will issue 95 additional Chapter II Grievances to be announced in public on Tuesdays at 11:00 am.

Declaration of Grievance

Statement of Facts

The people of California are suffering from a tyrannical state government which fails to provide a republican form of governance, enables and supports across its southern border the invasion of the United States of America by illegal foreign nationals and protects vicious criminals who commit outrageous acts of violence upon the Citizens of America all caused by a government of and for a mono-party system lead by a tyrannical dictator who openly defies federal law.

California State Government is in Direct Violation of the Following:

United States Constitution Article IV Section 4

"The United States shall guarantee to every state in this union a republican form of government, and shall protect each of them against invasion; and on application of the legislature, or of the executive (when the legislature cannot be convened) against domestic violence."

United States Constitution Article VI

This Constitution, and the Laws of the United States which shall be made in Pursuance thereof; and all Treaties made, or which shall be made, under the Authority of the United States, shall be the supreme Law of the Land; and the Judges in every State shall be bound thereby, any Thing in the Constitution or Laws of any State to the Contrary notwithstanding.

First Amendment of the United States Constitution

THE DICTATOR CLAIMS

HIS DOMINION

California Governor Claims “Dominion” Over U.S. Citizens Living and Doing Business in California State.

The governor of California issued an executive order declaring there would be no singing or chanting in churches in the state, no 4th of July parties or fireworks, and the state’s beaches closed. He also ordered the closures of restaurants, wineries, tasting rooms, movie theaters, family entertainment centers, zoos, museums, cardrooms and bars in 19 counties. The governor exempted Napa County, where he owns the Plumpjack Winery. *Plumpjack winery was financed in part by Gordon Getty and Nancy Pelosi.*

The governor’s order stated:

“In particular, activities such as singing and chanting negate the risk reduction achieved through six feet of physical distancing. Places of worship must therefore discontinue singing and chanting activities and limit indoor attendance to 25% of building capacity or a maximum of 100 attendees, whichever is lower.”

“Even with adherence to physical distancing, convening in a congregational setting of multiple different households to practice a personal faith carries a relatively higher risk for widespread transmission of the COVID-19 virus, and may result in increased rates of infection, hospitalization, and death, especially among more vulnerable populations.”

To further his dictatorial reign of terror the governor formed “*multi-agency strike teams*” to punish “people who are thumbing their noses” at restrictions. He then threatened counties with a loss of state funds (funds the governor does not have) if they failed to follow his dictate.

Since March 4, 2020 the governor has usurped all power from the state legislature through using California’s state-of-emergency rules, due to the Covid-19 pandemic.

The governor was the first governor in the U.S. to [declare a state of emergency](#), giving him complete control over the legislature. Since then the California dictator has issued 40 Executive Orders, unilaterally changing over 200 laws covering most sections of the California state law.

What the California governor has effectively achieved is the destruction of the little federal (state government) model of governance which requires that there be three branches of government that are co-equal in power. The little federal model based upon the federal model (U.S. Government) of government which requires three co-equal power branches of government, the Legislature, Judiciary and the Executive.

Today California enjoys the status of having only two branches of government a feckless judiciary and a dictatorship as an executive branch. The legislature is all but destroyed and powerless to stop the executive branch. The March 4, 2020 usurpation of the legislative power by his declared state of emergency will continue indefinitely since there are no time limits on the governor's emergency order those time limits were removed by the legislature in 2015.

When the Founding Fathers came together to write the constitution they knew that the People with their God Given Rights were responsible for the government and they were very concerned that the People could be compromised by a government in which one of the branches would be more powerful than another thus throwing the entire power balance of the three co-equal branches into a tail spin. The Founding Fathers knew that with one branch weakened there would be a collapse of the three branches altogether into a one-power system known as a dictatorship.

The Founding Fathers dreaded a moment like this for the states and put into the Constitution methods to deal with a dictator such as seen now in California. The Founders answer was the making of new state found in the "*New State Clause*" of the *U.S. Constitution Article IV, Section 3*. Article IV, Section 3 has only been utilized on three occasions in the formation of all 50 states. The last time Article IV, Section 3 was utilized was at the start of the Civil War in 1861 with the formation of West Virginia.

New California State movement has for over 5 years has been utilizing Article IV, Section 3 to form a new state in direct defiance of a dictator just like the Founding Fathers had planned.

The California governor is a pusillanimous craven dictator whose words and actions are a grave danger to all U.S. Citizens living in California.

California is a failed state operating outside the authorities of the U.S. Constitution violating Articles IV, Section 4, Article VI and the Fourth Amendment.

For New Californian's its our **GOD** given "*Right it is our Duty*" to protect our Declaration of Independence, our Constitution and our Bill of Rights with all means necessary from a craven dictator.

We request the **President of the United States** act immediately to remedy these abuses by the establishment of the New California State.

Insurrection

The government of California, the current socialist governor/dictator and mono-party system along with local officials are following a coordinated design with the intent to actively engage in **acts of insurrection** against the U.S. Constitution.
