Grievance 13

New California is a new state in development exercising its Constitutional Right to form from the State of California. The process to form New California is authorized and codified in Article IV Sections 3 & 4 of the United States Constitution.

Statement of Intent

The Citizens of New California have decided to remedy the abuse of power by the government of California by exercising their right to form a new state provided in United States Constitution Article IV Sections 3 and Section 4.

“We are determined to live under a State Government in the United States of America and under the Constitution of the United States.”

New California Declaration of Independence of

January 15, 2018 states:

“Whenever any Form of Government becomes destructive it is the Right of the People to alter or to abolish it, and to institute new Government.

When a long train of abuses and acts to seize and hold the people’s power without legal authority and pursuing invariably the same Object that clearly demonstrates a design to reduce them under absolute Despotism, it is their Right, it is their Duty, to throw off such Government, and to provide new Guards for their future security.

Preamble of the New California State Constitution states:

We, the representatives of the undersigned Counties within the State of California, do acknowledge and humbly invoke the favor of Almighty God for continued civil and religious liberty to ourselves and our posterity....

First Amendment of the United States Constitution states:

"Congress shall make no law respecting an establishment of religion, or prohibiting the free exercise thereof; or abridging the freedom of speech, or of the press; or the right of the people peaceably to assemble, and to petition the government for a redress of grievances."

Fourth Amendment of the United States Constitution states:

The right of the people to be secure in their persons, houses, papers, and effects, against unreasonable searches and seizures, shall not be violated, and no warrants shall issue, but upon probable cause, supported by oath or affirmation, and particularly describing the place to be searched, and the persons or things to be seized.

The Counties of New California State brought forward 95 Chapter I Grievances between January 2018 and November 2019. On April 28, 2020 New California State will issue 95 additional Chapter II Grievances to be announced in public on Tuesdays at 11:00 am.

Declaration of Grievance

Statement of Facts

California State Government is in Direct Violation of the Following:

United States Constitution Article IV Section 4

"The United States shall guarantee to every state in this union a republican form of government, and shall protect each of them against invasion; and on application of the legislature, or of the executive (when the legislature cannot be convened) against domestic violence."

United States Constitution Article VI

This Constitution, and the Laws of the United States which shall be made in Pursuance thereof; and all Treaties made, or which shall be made, under the Authority of the United States, shall be the supreme Law of the Land; and the Judges in every State shall be bound thereby, any Thing in the Constitution or Laws of any State to the Contrary notwithstanding.

California Governor Has Been Doinked

In an interview with Fox News Chris Wallace President Donald Trump destroyed an attempt by the leftist reporter to tar him with the sins of the left.

Chris Wallace is the son of Mike Wallace the famous leftist CBS reporter of 60 minutes fame and who is walking in his father's footsteps as the leading leftist on Fox News.

President Trump brings up a major issue when asked about kids returning to school in the fall while liberal governors of several states including California have stated they will not open schools.

In the case of the California dictator Governor he has pledged to keep schools closed even though the state constitution supersedes his authority and demands schools be open to educate students.

For those who saw the Chris Wallace interview with President Trump the President made it clear there would be NO money coming to states who do not open school for the fall.

“Schools have to open, young people have to go to school, and there’s problems when you don’t go to school”. “And there’s going to be a funding problem when they don’t open the schools, we’re not going to fund them, let the schools open”. This a very clear message to the California dictator that the President is thinking of the kids first while as you would suspect the dictator is only thinking about himself.

This is the moment in which the California dictator with his state budget is at the edge of the cliff. All that is needed is just a little “DOINK” push with the little finger to send California into financial insurrection and off the cliff. Its clear President Trump provided the little finger.

What the President needs to do is arrest the California dictator, the former governor Jerry Brown along with the Speaker of the U.S. House of Representatives Nancy Pelosi who colluded and illegally put pressure on former federal officials to advantage themselves with federal dollars by way of the California state budgeting process.

Article IV, Section 3 has only been utilized on three occasions in the formation of all 50 states. The last time Article IV, Section 3 was utilized was at the start of the Civil War in 1861 with the formation of West Virginia.

New California State movement has for over 5 years has been utilizing Article IV, Section 3 to form a new state in direct defiance of the California dictator just like the Founding Fathers had planned. New Californians will **NOT** comply.

The California governor is a pusillanimous craven dictator whose words and actions are a grave danger to all U.S. Citizens living in California while the state continues to operate outside the authorities of the U.S. Constitution violating Articles IV, Section 4, Article VI, the First and Fourth Amendments.

For New Californian’s its our **GOD** given “*Right it is our Duty*” to protect our Declaration of Independence, our Constitution and our Bill of Rights with all means necessary from a craven dictator.
