# Grievance 23

New California is a new state in development exercising its Constitutional Right to form from the State of California. The process to form New California is authorized and codified in Article IV Sections 3 & 4 of the United States Constitution.

### Statement of Intent

The Citizens of New California have decided to remedy the abuse of power by the government of California by exercising their right to form a new state provided in United States Constitution Article IV Sections 3 and Section 4.

*“We are determined to live under a State Government in the United States of America and under the Constitution of the United States.”*

### New California Declaration of Independence of

January 15, 2018 states:

*“Whenever any Form of Government becomes destructive it is the Right of the People to alter or to abolish it, and to institute new Government.*

*When a long train of abuses and acts to seize and hold the people’s power without legal authority and pursuing invariably the same Object that clearly demonstrates a design to reduce them under absolute Despotism, it is their Right, it is their Duty, to throw off such Government, and to provide new Guards for their future security.*

**Preamble of the New California State Constitution states:**

*We, the representatives of the undersigned Counties within the State of California, do acknowledge and humbly invoke the favor of Almighty God for continued civil and religious liberty to ourselves and our posterity....*

**First Amendment of the United States Constitution states:**

**"Congress shall make no law respecting an establishment of religion, or prohibiting the free exercise thereof; or abridging the freedom of speech, or of the press; or the right of the people peaceably to assemble, and to petition the government for a redress of grievances."**

**Fourth Amendment of the United States Constitution states:**

***The right of the people to be secure in their persons, houses, papers, and effects, against unreasonable searches and seizures, shall not be violated, and no warrants shall issue, but upon probable cause, supported by oath or affirmation, and particularly describing the place to be searched, and the persons or things to be seized.***

The Counties of New California State brought forward 95 Chapter I Grievances between January 2018 and November 2019. On April 28, 2020 New California State will issue 95 additional Chapter II Grievances to be announced in public on Tuesdays at 11:00 am.

## Declaration of Grievance Statement of Facts

The people of California are suffering from a tyrannical state government which fails to provide a republican form of governance, enables and supports across its southern border the invasion of the United States of America by illegal foreign nationals and protects vicious criminals who commit outrageous acts of violence upon the Citizens of America all caused by a government of and for a mono-party system lead by a tyrannical dictator who openly defies federal law.

### **United States Constitution Article VI**

*This Constitution, and the Laws of the United States which shall be made in Pursuance thereof; and all Treaties made, or which shall be made, under the Authority of the United States, shall be the supreme Law of the Land; and the Judges in every State shall be bound thereby, any Thing in the Constitution or Laws of any State to the Contrary notwithstanding.*

### **First Amendment, United States Constitution**

### **Eighth Amendment, United States Constitution**

*Excessive bail shall not be required, nor excessive fines imposed, nor cruel and unusual punishments inflicted.*

### **Fourteenth Amendment, United States Constitution**

*Section 1. All persons born or naturalized in the United States, and subject to the jurisdiction thereof, are citizens of the United States and of the State wherein they reside. No State shall make or enforce any law which shall abridge the privileges or immunities of citizens of the United States; nor shall any State deprive any person of life, liberty, or property, without due process of law; nor deny to any person within its jurisdiction the equal protection of the laws. # ORDER OF THE DAY

## ARREST THE SPEAKER OF THE STATE ASSEMBLY

While *We*, the People, of the Unified Counties of New California seek the removal of the California state SPEAKER OF THE ASSEMBLY - Anthony Rendon (born March 4, 1968) who is now serving as the 70th Speaker of the California State Assembly since 2016. A member of the Democratic Party, Rendon has represented the 63rd district, located in the southeastern part of Los Angeles County, since 2012.

The Speaker of the Assembly is the presiding officer of the Assembly and is elected for a two-year term by a majority vote of the Members. He or she is charged with the overall management and supervision of the Assembly. The Speaker appoints members to all committees and subcommittees of the Assembly, allocates funds, staffing and other resources for the effective operation of the House, and establishes the committee schedules (A.R. 26).

On **February 19, 2020** Speaker Rendon reacted to the state of the state address by California governor Newsom when he commented on housing and poverty by stating:

*The Governor has put out budget proposals on this topic and we take them very seriously. Today, we will hold our second Assembly hearing on those ideas.*

*We have worked well together in the past, with the Governor signing 18 of our legislative housing initiatives. **We have set aside \$7 billion for housing solutions in recent years.***

*However, when the Governor refers to the need for “bold, permanent solutions,” I know that those solutions go beyond the necessary dollars for housing, mental health, planning and social services.*

*This country has a dramatic problem of economic inequality that has grown for decades. Homelessness, as the Governor said, is a manifestation of poverty. To me, that means that Californians will continue to lose their housing and will be unable to find new affordable housing, unless we can do something to make sure California workers get their fair share of the wealth that they produce.*

*They are the drivers of our economy. We must make sure they are protected. I look forward to working with Governor Newsom to fight homelessness on every front.”*

On **June 3, 2020** the California state senate and assembly reached agreement on 2020-21 Budget. Assembly Speaker Anthony Rendon stated:

*“The key budget goal is preserving programs serving those who are most vulnerable. Nevertheless, all the budget plans being discussed acknowledge the possibility that more difficult cuts will be necessary, due to COVID spending needs and weak revenues,” said Rendon. “This will be especially true if Washington, D.C. doesn't step up. The Legislature is prepared to work closely with the Governor to achieve California's goals. That's how, over the past decade, **we built the large budget reserve that now helps us face the fiscal crisis.**”*

The current assembly speaker provides just a small amount of evidence in the two above comments as to why he should be arrested, charged and sent to prison. The speaker on February 19, 2020 stated: “*We have set aside \$7 billion for housing solutions in recent years*”. Today we must ask where is this money that was set aside? The reality there never was \$7 billion to set aside. The speaker was deliberately misleading and lying to the public.

On June 3, 2020 the speaker stated: *we built the large budget reserve that now helps us face the fiscal crisis.* Today we must ask where is this “large budget reserve”? The speaker and governor claimed the reserve was \$13 billion. Where is the \$13 billion? The reality is there never was a \$13 billion reserve. The speaker was deliberately misleading and lying to the public.

Law makers in Sacramento have called for "extraordinary session of the state legislature" to consider reopening the economy. **According to numerous sources in the California state capital there will be a 'special' legislative session in the coming weeks to discuss the state's massive financial crisis and repeal the governor's *Emergency Services Act*.** The speaker disagrees. Why?

Governor Newsom signed an [executive order March 4, 2020](#) known as the *Emergency Services Act under Government Code Section 8625* in response to the Covid-19 pandemic which has crippled the California economy and destroyed the lives of millions of people in California.

As identified by the New California State movement California is in default on filing the necessary federal financial forms that will allow the continuation of over \$97 billion of annual federal grants. The failure of the state to file the necessary documents the federal government requires has triggered a number of investigations both by the federal and state government into the financial accountings of the state and the actions of the governor. “The state is now over \$100 billion short of cash and is no longer solvent”.

***The signing of the *Emergency Services Act* has exacerbated the financial crisis and created a dictatorship that consolidates legislative and judicial branches of government under the office of the governor. California is the first one-man rule dictatorship in United States history.***

The speaker to this day is not working to solve the problems facing California. His inaction is destroying the lives of millions of Californians and destroying the state's economy. Its clear there are numerous violations of law and the constitutional oath taken by the speaker.

New California State will pursue every means available to remedy the speaker's abuse of power and illegal felonious acts. *We* now demand the California state legislature exercise the limited powers it has at its discretion to repeal the *governor's* unlimited powers of authority he is utilizing to destroy the state's economy while furthering his reign of terror upon the United States Citizens living in the state of California.

New California State movement has for over 5 years been utilizing Article IV, Section 3 to form a new state in direct defiance of the California dictator just like the Founding Fathers had planned when they wrote the U.S. Constitution.

The California governor is a ***pusillanimous*** craven dictator whose words and actions are a grave danger to all U.S. Citizens living in California while the state continues to operate outside the authorities of the U.S. Constitution.

For New Californian's its our **GOD** given "***Right it is our Duty***" to protect our Declaration of Independence, our Constitution and our Bill of Rights with all means necessary from a craven dictator. *New Californians will NOT comply.*

We request the **President of the United States** act immediately to remedy these abuses by the establishment of the New California State.

## **Insurrection**
