New California is a new state in development exercising its Constitutional Right to form from the State of California. The process to form New California is authorized and codified in Article IV Sections 3 & 4 of the United States Constitution.

Statement of Intent

The Citizens of New California have decided to remedy the abuse of power by the government of California by exercising their right to form a new state provided in United States Constitution Article IV Sections 3 and Section 4.

“We are determined to live under a State Government in the United States of America and under the Constitution of the United States.”

New California Declaration of Independence of January 15, 2018 states:

“Whenever any Form of Government becomes destructive it is the Right of the People to alter or to abolish it, and to institute new Government.

*When a long train of abuses and acts to seize and hold the people’s power without legal authority and pursuing invariably the same Object that clearly demonstrates a design to reduce them under absolute Despotism, it is their **Right, it is their Duty**, to throw off such Government, and to provide new Guards for their future security.*

Preamble of the New California State Constitution states:

We, the representatives of the undersigned Counties within the State of California, do acknowledge and humbly invoke the favor of Almighty God for continued civil and religious liberty to ourselves and our posterity....

First Amendment of the United States Constitution states:

"Congress shall make no law respecting an establishment of religion, or prohibiting the free exercise thereof; or abridging the freedom of speech, or of the press; or the right of the people peaceably to assemble, and to petition the government for a redress of grievances."

Fourth Amendment of the United States Constitution states:

The right of the people to be secure in their persons, houses, papers, and effects, against unreasonable searches and seizures, shall not be violated, and no warrants shall issue, but upon probable cause, supported by oath or affirmation, and particularly describing the place to be searched, and the persons or things to be seized.

The Counties of New California State brought forward 95 Chapter I Grievances between January 2018 and November 2019. On April 28, 2020 New California State will issue 95 additional Chapter II Grievances to be announced in public on Tuesdays at 11:00 am.

Declaration of Grievance Statement of Facts

The people of California are suffering from a tyrannical state government which fails to provide a republican form of governance, enables and supports across its southern border the invasion of the United States of America by illegal foreign nationals and protects vicious criminals who commit outrageous acts of violence upon the Citizens of America all caused by a government of and for a mono-party system lead by a tyrannical dictator who openly defies federal law.

California State Government Violates the Following: United States Constitution Article IV Section 4

"The United States shall guarantee to every state in this union a republican form of government, and shall protect each of them against invasion; and on application of the legislature, or of the executive (when the legislature cannot be convened) against domestic violence."

United States Constitution Article VI

This Constitution, and the Laws of the United States which shall be made in Pursuance thereof; and all Treaties made, or which shall be made, under the Authority of the United States, shall be the supreme Law of the Land; and the Judges in every State shall be bound thereby, any Thing in the Constitution or Laws of any State to the Contrary notwithstanding.

First Amendment, United States Constitution

"Congress shall make no law respecting an establishment of religion, or prohibiting the free exercise thereof; or abridging the freedom of speech, or of the press; or the right of the people peaceably to assemble, and to petition the government for a redress of grievances."

Fourteenth Amendment, United States Constitution

Section 3. *No Person shall be a Senator or Representative in Congress, or elector of President and Vice-President, or hold any office, civil or military, under the United States, or under any State, who, having previously taken an oath, as a member of Congress, or as an officer of the United States, or as a member of any State legislature, or as an executive or judicial officer of any State, to support the Constitution of the United States, shall have engaged in insurrection or rebellion against the same, or given aid or comfort to the enemies thereof. But Congress may by a vote of two-thirds of each House, remove such disability.*

Affidavits are Your Own Personal Grievance

FIFTH ELEMENT OF THE 1ST AMENDMENT

In Grievance 59 New California State stated that *New California Patriot Citizens are taking action. No longer content to see nothing being done by a totalitarian government from Sacramento who levies outrageous taxes without representation then destroys the lives of millions of citizens through forced vaccinations, denial of constitutional rights, school closures and business destruction.*

Now New California State Citizens are taking action against the totalitarian dictator governor and his fellow legislative henchmen through a simple Constitutional process that requires courage in the face of terror. "Process" is feared by the totalitarian because in process where the United States Constitution is concerned is where you find courage and Devine Truth.

The affidavit process has been around before the Constitution was written by the Founding Fathers. It represents a Citizens personal Grievance. An **affidavit** (Medieval Latin for *he has declared under oath*) is a written statement of fact voluntarily made by an *affiant* or deponent under an oath or affirmation which is administered by a person who is authorized to do so by law. Such a statement is witnessed as to the authenticity of the affiant's signature by a taker of oaths, such as a notary public or commissioner of oaths. An affidavit is a type of verified statement or showing, or in other words, it contains a verification, which means that it is made under oath on penalty of perjury, and this serves as evidence for its veracity and is required in court proceedings.

Affidavits/Declarations enable an individual to personally express not only their *grievance*; but an individual's loss as well. They have a 10 day "cure" response time once they are delivered to the affidavit recipient where the affidavit recipient can respond to the affiant. After the ten days, the sheriff can receive the affidavits for investigation. If the investigation pans out, the office holder can be removed by the sheriff--fast, inexpensive and without political bias.

New California State continues to educate people about the grave issues WE face as the ***pusillanimous*** totalitarian dictator acting along side a complicit legislature and judiciary continue to force unconstitutional edicts upon WE the PEOPLE which result in lawlessness that is destroying millions of lives.

ASSUMPTIONS THAT UNDERGIRD THE STATEMENTS IN AN AFFIDAVIT

To state the doctrine most simply, to establish a government with Limited Powers, as the Framers plainly outlined, do not give powers away in the first place.

Our Founding Fathers used this same structural concept of Limited Powers when delegating power to State and Local governments: The powers are inherent in the individual, and the individuals, as a group, delegate some of those inherent powers to State and to the Local government.

What is significant about the individual's delegation of powers to Federal, State, and Local government is that the individual still maintains a share of the powers he or she delegated to the government. Thus, the American Constitutional Republic is still guided by "We the People."

Key to "We the People" retaining their share of the delegated powers is that those in government exercising those powers must be above reproach in administering their delegated powers fairly and even-handedly. This is especially true regarding voting. "We the People" must have confidence that both their votes and the votes of the opposition are fairly and accurately counted.

SIGNIFICANCE OF THESE FOUNDATIONAL TRUTHS

The significance of America being a Constitutional Republic is that the Constitution is the Supreme Law of this Land. Any purported "law," statute, code, regulation, rule or policy made consistently with the enumerated powers of the Constitution are presumed valid. In contrast, any purported law, statute, code, regulation, rule or policy, which opposes and/or violates the Constitution in any way, whatsoever, is lawfully null and void. *No bureaucrat, politician, or person acting in an official capacity has any legal authority to restrict the Constitutional rights of any law-abiding citizen, nor alter the count of the citizen's votes.*

California's mono-party political machine, its socialist Governor, along with communist state legislators, socialist elected officials, agencies, and unelected regional governance boards, are colluding to create a Pure Totalitarian Communist California state.

All of our Founding Fathers exemplified the spirit of *tenacity*.
