## Chapter II

# Grievance 93

February 1, 2022

New California is a new state in development exercising its Constitutional Right to form from the State of California. The process to form New California is authorized and codified in Article IV Sections 3 & 4 of the United States Constitution.

### Statement of Intent

The Citizens of New California have decided to remedy the abuse of power by the government of California by exercising their right to form a new state provided in United States Constitution Article IV Sections 3 and Section 4.

*“We are determined to live under a State Government in the United States of America and under the Constitution of the United States.”*

### New California Declaration of Independence of January 15, 2018 states:

*“Whenever any Form of Government becomes destructive it is the Right of the People to alter or to abolish it, and to institute new Government.*

*When a long train of abuses and acts to seize and hold the people’s power without legal authority and pursuing invariably the same Object that clearly demonstrates a design to reduce them under absolute Despotism, it is their Right, it is their Duty, to throw off such Government, and to provide new Guards for their future security.*

## **Preamble of the New California State Constitution states:**

*We, the representatives of the undersigned Counties within the State of California, do acknowledge and humbly invoke the favor of Almighty God for continued civil and religious liberty to ourselves and our posterity....*

## **First Amendment of the United States Constitution states:**

**"Congress shall make no law respecting an establishment of religion, or prohibiting the free exercise thereof; or abridging the freedom of speech, or of the press; or the right of the people peaceably to assemble, and to petition the government for a redress of grievances."**

## **Fourth Amendment of the United States Constitution states:**

**The right of the people to be secure in their persons, houses, papers, and effects, against unreasonable searches and seizures, shall not be violated, and no warrants shall issue, but upon probable cause, supported by oath or affirmation, and particularly describing the place to be searched, and the persons or things to be seized.**

The Counties of New California State brought forward 95 Chapter I Grievances between January 2018 and November 2019. On April 28, 2020 New California State will issue 95 additional Chapter II Grievances to be announced in public on Tuesdays at 11:00 am.

# Grievance 93

### Declaration of Grievance Statement of Facts

The people of California are suffering from a tyrannical state government which fails to provide a republican form of governance, enables and supports across its southern border the invasion of the United States of America by illegal foreign nationals and protects vicious criminals who commit outrageous acts of violence upon the Citizens of America all caused by a government of and for a mono-party system lead by a tyrannical dictator who openly defies federal law.

### **CALIFORNIA STATE VIOLATES:**

#### United States Constitution Article IV Section 4

*"The United States shall guarantee to every state in this union a republican form of government, and shall protect each of them against invasion; and on application of the legislature, or of the executive (when the legislature cannot be convened) against domestic violence."*

#### United States Constitution Article VI

*This Constitution, and the Laws of the United States which shall be made in Pursuance thereof; and all Treaties made, or which shall be made, under the Authority of the United States, shall be the supreme Law of the Land; and the Judges in every State shall be bound thereby, any Thing in the Constitution or Laws of any State to the Contrary notwithstanding.*

#### First Amendment, United States Constitution

*"Congress shall make no law respecting an establishment of religion, or prohibiting the free exercise thereof; or abridging the freedom of speech, or of the press; or the right of the people peaceably to assemble, and to petition the government for a redress of grievances."*

#### Fourteenth Amendment, United States Constitution

**Section 3.** *No Person shall be a Senator or Representative in Congress, or elector of President and Vice-President, or hold any office, civil or military, under the United States, or under any State, who, having previously taken an oath, as a member of Congress, or as an officer of the United States, or as a member of any State legislature, or as an executive or judicial officer of any State, to support the Constitution of the United States, shall have engaged in insurrection or rebellion against the same, or given aid or comfort to the enemies thereof. But Congress may by a vote of two-thirds of each House, remove such disability.*

## *AN ACT IN*

## DEFAULT



*The Compromise of 1850 admitted California as a state of the Union.*

## IN CONGRESS SEPTEMBER 9, 1850

### **An Act for the admission of the State of California into the Union.**

Whereas the people of California have presented a constitution and asked admission into the Union, which constitution was submitted to Congress by the President of the United States, by message dated February thirteenth, eighteen hundred and fifty, and which, on due examination, is found to be *republican* in its form of government:

#### **Section 1**

Be it enacted by the Senate and House of Representatives of the United States of America in Congress assembled, That the State of California shall be one, and is hereby declared to be one, of the United States of America, and admitted into the Union on an equal footing with the original States in all respects whatever.

#### **Section 2**

And be it further enacted, That, until the representatives in Congress shall be apportioned according to an actual enumeration of the inhabitants of the United States, the State of California shall be entitled to two representatives in Congress.

### Section 3

And be it further enacted, That the said State of California is admitted into the Union upon the express condition that the people of said State, through their legislature or otherwise, shall never interfere with the primary disposal of the public lands within its limits, and shall pass no law and do no act whereby the title of the United States to, and right to dispose of, the same shall be impaired or questioned; and that they shall never lay any tax or assessment of any description whatsoever upon the public domain of the United States, and in no case shall non-resident proprietors, who are citizens of the United States, be taxed higher than residents; and that all the navigable waters within the said State shall be common highways, and forever free, as well to the inhabitants of said State as to the citizens of the United States, without any tax, impost, or duty therefore: Provided, That nothing herein contained shall be construed as recognizing or rejecting the propositions tendered by the people of California as articles of *compact* in the ordinance adopted by the convention which formed the constitution of that State.

APPROVED, September 9, 1850.

## NOTICE OF DEFAULT

*State of California is in Default for violating its compact as agreed in its 1850 State Constitution and agreed in its admission whereas the people of California presented a constitution and asked admission into the Union, which constitution was submitted to Congress by the President of the United States, by message dated February thirteenth, eighteen hundred and fifty, and which, on doe examination, was found to be republican in its form of government,*

*Further in Section 1 of the November 9, 1850 Bill it was enacted by the Senate and House of Representatives of the United States of America in Congress assembled, that the State of California shall be one, and was thereby declared to be one, of the United States of America, and admitted into the Union on an equal footing with the original States in all respects whatever.*

*As of December 1, 2021 California fails to provide a republican form of government, is in financial default and does not have equal footing with all the original States in all aspects whatever thus Violating Article IV and Article VI of the United State Constitution ratified June 21, 1788.*

*To the and does not have United States Constitutional Standing as a member State in the Union of States called the United States of America.*

## **California is in Default of the United States Constitution**

Article IV, Sections 1 & 4.

### **Section 1**

*Full Faith and Credit shall be given in each State to the public Acts, Records, and judicial Proceedings of every other State. And the Congress may by general Laws prescribe the Manner in which such Acts, Records and Proceedings shall be proved, and the Effect thereof.*

### **Section 4**

*The United States shall guarantee to every State in this Union a Republican Form of Government, and shall protect each of them against Invasion; and on Application of the Legislature, or of the Executive (when the Legislature cannot be convened) against domestic Violence.*

## **California is in Default of the United States Constitution**

Article VI, Sections 1, 2, 3

### **Section 1**

*All debts contracted and engagements entered into, before the adoption of this Constitution, shall be as valid against the United States under this Constitution, as under the Confederation.*

### **Section 2**

*This Constitution, and the laws of the United States which shall be made in pursuance thereof; and all treaties made, or which shall be made, under the authority of the United States, shall be the supreme law of the land; and the judges in every state shall be bound thereby, anything in the Constitution or laws of any State to the contrary notwithstanding.*

### **Section 3**

*The Senators and Representatives before mentioned, and the members of the several state legislatures, and all executive and judicial officers, both of the United States and of the several states, shall be bound by oath or affirmation, to support this Constitution; but no religious test shall ever be required as a qualification to any office or public trust under the United States.*

## **STATE OF CALIFORNIA IS DECLARED IN DEFAULT OF THE U.S. CONSTITUTION**

**The State of California is no longer in good standing as a member of the Union of States known as the United States of America.**

In New California State, we echo the thoughts, convictions, principles, and ideals of the Founders of the United States of America. We will retain our humanity, our natural and unalienable rights, and our autonomy, free from the shackles of slavery to *any form of government*.

## **Insurrection**

The government of California, the current socialist governor/dictator and mono-party system along with local officials are following a coordinated design with the intent to actively engage in “*Acts of Insurrection*” against the U.S. Constitution.

The **Insurrection Act of 1807** and the *Emergency Economic Powers Act* are United **States** federal laws that govern the ability of the President of the United States to deploy military troops within the United States to put down lawlessness insurrection, and rebellion.

## **Acts of Secession**

The California government in conjunction with the socialist state executive, instituted wherever the current socialist governor/dictator has usurped power has actively engaged in “*Acts of Secession*” and have created a reign of terror on United States Citizens living in California with the intent to **secede** from the United States of America to thus destroy the very **Union of States** which secures our **Liberty and Freedom**.

## **Abdication of Authority**
