# Grievance 94

February 8, 2022

New California is a new state in development exercising its Constitutional Right to form from the State of California. The process to form New California is authorized and codified in Article IV Sections 3 & 4 of the United States Constitution.

## Statement of Intent

The Citizens of New California have decided to remedy the abuse of power by the government of California by exercising their right to form a new state provided in United States Constitution Article IV Sections 3 and Section 4.

*“We are determined to live under a State Government in the United States of America and under the Constitution of the United States.”*

## New California Declaration of Independence of January 15, 2018 states:

*“Whenever any Form of Government becomes destructive it is the Right of the People to alter or to abolish it, and to institute new Government.*

*When a long train of abuses and acts to seize and hold the people’s power without legal authority and pursuing invariably the same Object that clearly demonstrates a design to reduce them under absolute Despotism, it is their Right, it is their Duty, to throw off such Government, and to provide new Guards for their future security.*

## **Preamble of the New California State Constitution states:**

*We, the representatives of the undersigned Counties within the State of California, do acknowledge and humbly invoke the favor of Almighty God for continued civil and religious liberty to ourselves and our posterity....*

## **First Amendment of the United States Constitution states:**

**"Congress shall make no law respecting an establishment of religion, or prohibiting the free exercise thereof; or abridging the freedom of speech, or of the press; or the right of the people peaceably to assemble, and to petition the government for a redress of grievances."**

## **Fourth Amendment of the United States Constitution states:**

**The right of the people to be secure in their persons, houses, papers, and effects, against unreasonable searches and seizures, shall not be violated, and no warrants shall issue, but upon probable cause, supported by oath or affirmation, and particularly describing the place to be searched, and the persons or things to be seized.**

The Counties of New California State brought forward 95 Chapter I Grievances between January 2018 and November 2019. On April 28, 2020 New California State will issue 95 additional Chapter II Grievances to be announced in public on Tuesdays at 11:00 am.

# Grievance 94

### Declaration of Grievance Statement of Facts

The people of California are suffering from a tyrannical state government which fails to provide a republican form of governance, enables and supports across its southern border the invasion of the United States of America by illegal foreign nationals and protects vicious criminals who commit outrageous acts of violence upon the Citizens of America all caused by a government of and for a mono-party system lead by a tyrannical dictator who openly defies federal law.

### **CALIFORNIA STATE VIOLATES:**

#### United States Constitution Article IV Section 4

*"The United States shall guarantee to every state in this union a republican form of government, and shall protect each of them against invasion; and on application of the legislature, or of the executive (when the legislature cannot be convened) against domestic violence."*

#### United States Constitution Article VI

*This Constitution, and the Laws of the United States which shall be made in Pursuance thereof; and all Treaties made, or which shall be made, under the Authority of the United States, shall be the supreme Law of the Land; and the Judges in every State shall be bound thereby, any Thing in the Constitution or Laws of any State to the Contrary notwithstanding.*

#### First Amendment, United States Constitution

*"Congress shall make no law respecting an establishment of religion, or prohibiting the free exercise thereof; or abridging the freedom of speech, or of the press; or the right of the people peaceably to assemble, and to petition the government for a redress of grievances."*

#### Fourteenth Amendment, United States Constitution

**Section 3.** *No Person shall be a Senator or Representative in Congress, or elector of President and Vice-President, or hold any office, civil or military, under the United States, or under any State, who, having previously taken an oath, as a member of Congress, or as an officer of the United States, or as a member of any State legislature, or as an executive or judicial officer of any State, to support the Constitution of the United States, shall have engaged in insurrection or rebellion against the same, or given aid or comfort to the enemies thereof. But Congress may by a vote of two-thirds of each House, remove such disability.*

# ORDER OF THE DAY

## *LIBERTY OR DEATH*

In 1776 the Declaration of Independence declared LIBERTY for the East Coast of the Americas and the 13 Colonies for what would soon become the United States of America. A county that would liberate the colonies from British control.

Over 3,000 miles away on the West Coast Spaniards sought to *claim the lands* by building 21 missions from 1769 to 1823. The missions were built approximately 30 miles apart—about a day’s journey by horseback—covering 650 miles total. To make sure travelers could find their way from one mission to another the missionaries spread European mustard seeds along the trails between each mission thus insuring the glow of yellow flowers for spring time travelers.

California's 21 Missions were a fraction of over 100 missions that were built by Spaniards in their quest to claim vast holdings in North America. Missions were built from Mexico to California to Arizona, New Mexico, Texas, Mississippi and into Florida. In 1810 to 1812 two Declarations of Independence were written to declare liberty for the people of West and East Florida respectively from Spanish rule. Then in 1821 Mexico declared independence from Spain. Both California and Texas which were colonies of Mexico for 3 years both declared their independence from Mexico in 1836.

The goal of the Spanish government was to recruit local natives, then convert, educate, and civilize the indigenous populations, turning them into Spanish colonial citizens. Total assimilation of indigenous populations (called neophytes or new believers) into European culture and the Catholic religion was a doctrine established in 1531 in Spain. Believing that it was possible to create self-sustaining mission villages, the government sent Franciscan and Jesuit "missionaries" from the Catholic church to help construct and operate each mission. The effort did introduce “modern” foods, trees, cultivation methods to produce wine, and livestock to areas where fish and wild game were meals of choice, but measles and other diseases also arrived, decimating entire native populations except for a few survivors.

Under the leadership of a Franciscan, Fr. Junipero Serra, the California mission system had been launched between 1769 and 1833. But when the *Mexican Congress passed the Act for the Secularization of the Missions of California on August 17, 1833*, it called for the *colonization* of both *Alta Province of Las Californias, New Spain* (current California in the U.S. is now known as the *Jesuit Province of California*) and Baja California (Mexico) from proceeds of the sale of the mission property to private interests.

Most missions fell into disrepair and along with the oppression by the “*Centralized Government*” of Mexico which was brought to bear on Texas and Alta California in the form of massive indulgences and military occupation both Texas and Alta California declared their independence in 1836. First Texas in March 1836 then Alta California in November 1836. On September 9, 1850 California was admitted into the Union of States known as the United States of America.

As of today February 8, 2022 the state of California has been declared in Constitutional Default by New California State. California has degraded into a province of China and past “masters” of untold oppression of the people of Alta California and present day California. California has returned to the roots of the very evil from which Independence was Declared in November 6, 1836. Evil such as child sex trafficking, invasion, slavery, economics serfdom, lawlessness, mass murder of children and the elderly.

## **DECEMBER 1, 2021 NOTICE OF DEFAULT**

*State of California is in Default for violating its compact as agreed in its 1850 State Constitution and agreed in its admission whereas the people of California presented a constitution and asked admission into the Union, which constitution was submitted to Congress by the President of the United States, by message dated February thirteenth, eighteen hundred and fifty, and which, on due examination, was found to be republican in its form of government,*

*Further in Section 1 of the November 9, 1850 Bill it was enacted by the Senate and House of Representatives of the United States of America in Congress assembled, that the State of California shall be one, and was thereby declared to be one, of the United States of America, and admitted into the Union on an equal footing with the original States in all respects whatever.*

*As of December 1, 2021 California fails to provide a republican form of government, is in financial default and does not have equal footing with all the original States in all aspects whatever thus Violating Article IV and Article VI of the United State Constitution ratified June 21, 1788.*

*California does not have United States Constitutional Standing as a member State in the Union of States called the United States of America.*
