# Grievance 95

February 15, 2022

New California is a new state in development exercising its Constitutional Right to form from the State of California. The process to form New California is authorized and codified in Article IV Sections 3 & 4 of the United States Constitution.

## Statement of Intent

The Citizens of New California have decided to remedy the abuse of power by the government of California by exercising their right to form a new state provided in United States Constitution Article IV Sections 3 and Section 4.

*“We are determined to live under a State Government in the United States of America and under the Constitution of the United States.”*

## New California Declaration of Independence of January 15, 2018 states:

*“Whenever any Form of Government becomes destructive it is the Right of the People to alter or to abolish it, and to institute new Government.*

*When a long train of abuses and acts to seize and hold the people’s power without legal authority and pursuing invariably the same Object that clearly demonstrates a design to reduce them under absolute Despotism, it is their Right, it is their Duty, to throw off such Government, and to provide new Guards for their future security.*

## **Preamble of the New California State Constitution states:**

*We, the representatives of the undersigned Counties within the State of California, do acknowledge and humbly invoke the favor of Almighty God for continued civil and religious liberty to ourselves and our posterity....*

## **First Amendment of the United States Constitution states:**

**"Congress shall make no law respecting an establishment of religion, or prohibiting the free exercise thereof; or abridging the freedom of speech, or of the press; or the right of the people peaceably to assemble, and to petition the government for a redress of grievances."**

## **Fourth Amendment of the United States Constitution states:**

**The right of the people to be secure in their persons, houses, papers, and effects, against unreasonable searches and seizures, shall not be violated, and no warrants shall issue, but upon probable cause, supported by oath or affirmation, and particularly describing the place to be searched, and the persons or things to be seized.**

The Counties of New California State brought forward 95 Chapter I Grievances between January 2018 and November 2019. On April 28, 2020 New California State will issue 95 additional Chapter II Grievances to be announced in public on Tuesdays at 11:00 am.

# Grievance 95

### Declaration of Grievance Statement of Facts

The people of California are suffering from a tyrannical state government which fails to provide a republican form of governance, enables and supports across its southern border the invasion of the United States of America by illegal foreign nationals and protects vicious criminals who commit outrageous acts of violence upon the Citizens of America all caused by a government of and for a mono-party system lead by a tyrannical dictator who openly defies federal law.

### **CALIFORNIA STATE VIOLATES:**

#### United States Constitution Article IV Section 4

*"The United States shall guarantee to every state in this union a republican form of government, and shall protect each of them against invasion; and on application of the legislature, or of the executive (when the legislature cannot be convened) against domestic violence."*

#### United States Constitution Article VI

*This Constitution, and the Laws of the United States which shall be made in Pursuance thereof; and all Treaties made, or which shall be made, under the Authority of the United States, shall be the supreme Law of the Land; and the Judges in every State shall be bound thereby, any Thing in the Constitution or Laws of any State to the Contrary notwithstanding.*

#### First Amendment, United States Constitution

*"Congress shall make no law respecting an establishment of religion, or prohibiting the free exercise thereof; or abridging the freedom of speech, or of the press; or the right of the people peaceably to assemble, and to petition the government for a redress of grievances."*

#### Fourteenth Amendment, United States Constitution

**Section 3.** *No Person shall be a Senator or Representative in Congress, or elector of President and Vice-President, or hold any office, civil or military, under the United States, or under any State, who, having previously taken an oath, as a member of Congress, or as an officer of the United States, or as a member of any State legislature, or as an executive or judicial officer of any State, to support the Constitution of the United States, shall have engaged in insurrection or rebellion against the same, or given aid or comfort to the enemies thereof. But Congress may by a vote of two-thirds of each House, remove such disability.*

# ORDER OF THE DAY

## RESIST TYRANNY

### Declaration of Independence

#### State of New California

January 15, 2018

**W**e hold these truths to be self-evident, that all Men are created equal, that they are endowed by their Creator with certain unalienable Rights, that among these are Life, Liberty, Property and the pursuit of happiness.

**T**o secure these rights, Governments are instituted among Men, deriving their just powers from the consent of the governed.

**W**hen in the Course of human events it becomes necessary for one people to dissolve the political bands which have connected them with another and to assume among the powers of the earth, the separate and equal station to which the Laws of Nature and of Nature's God entitle them they should declare the causes which cause them to separate.

**W**hensoever any Form of Government becomes destructive of these ends, it is the Right of the People to alter or to abolish it, and to institute new Government, laying its foundation on such principles and organizing its powers in such design that is most likely to effect their Safety and Happiness.

**G**overnments long established should not be changed for light and transient causes; and accordingly all experience has shown mankind is more disposed to suffer, while evils are sufferable than to right themselves by abolishing the forms to which they are accustomed.

**H**owever when a long train of abuses and acts to seize and hold the people's power without legal authority and pursuing invariably the same Object that clearly demonstrates a design to reduce them under absolute Despotism, *it is their Right, it is their Duty, to throw off such Government*, and to provide new Guards for their future security.

The history of the present Governor and Government of California is a history of repeated injuries and usurpations, all having in direct object the establishment of a *Tyranny* over the Counties of New California and the State of California.

Whenever any Form of Government becomes destructive of these ends, it is the Right of the People to seek a constitutional remedy to the abuse of powers.

We the people of the Counties of New California solemnly publish and declare these counties are, and of Right ought to be, a free and Independent State, that we strive to be free from the State of California, and that as a Free and Independent State, have full power to establish and maintain law and order, to promote general prosperity, and to do all other acts and things, which an Independent New California State may rightfully do.

We, therefore, the Representatives of the Counties of New California, appeal to the California Legislature and the Federal Congress to pass resolutions to create the State of New California.

And for the support of this Declaration, with a firm reliance on the protection of Divine Providence, we mutually pledge to each other our Lives, our Fortunes, and our Sacred Honor.

Between 1683 and 1834, Jesuit and Franciscan missionaries established a series of religious outposts “*Missions*” from today’s Baja California and Baja California Sur into present-day California.

In 1804 the establishment of *Provincia de las Californias* by New Spain gave rise to the administrative state of *Alta California* also known as *Nueva California*, or 'New California'.

On November 3, 1836 the Californios of Alta California Declared their Independence from the government of Mexico by declaring: “*California is free and it will cut off all relations with Mexico until the mother country cease being oppressed by the present ruling faction known as the central government*”.

**O**n June 14, 1846 the Bear Flag Revolt against the Mexican Government in Sonoma turned Alta California into a protectorate of the United States.

**T**he Provinces of Alta California were officially dissolved by a statehood *compact* made between the Congress of the United States of America and the *People of California* on November 9, 1850.

***New California State and the State of California are not provinces of any nation or world power or religion.***

**H**owever it is clear by the actions of the State of California government that old provincial ties have been reestablished, renewed, expanded and have direct command and control over all government officials state and local to such a degree as to have turned the State of California into a tyrannical dictatorship.

**A** provincial administrative state *now* exists in California in direct violation of the November 9, 1850 *compact* with the United States of America.

**W**e the Citizens of the State of New California have Petitioned for Redress of Grievances in the most humble terms. Reading a total of one hundred ninety Grievances at County Courthouse locations within the borders of New California State during the course of four years.

**N**or have *We the Citizens of the State of New California* been wanting in attentions to our California brethren but our repeated Petitions have been answered only by repeated injury.

**A** Governor, whose character is thus marked by every act which may define a tyrant, is unfit to be the elected Governor of a free people. Likewise, *Elected, Appointed and Regional Officials* of the State of California whose character is thus marked by every act which may define a tyrant, are unfit to be the Elected, Appointed and Regional Officials of a free people.

**G**overnors and Officials of the State of California have exhibited Evidence of Tyranny and Treason against the Citizens, Counties, Towns and Cities of the State of California:



The history of the present Governor of California, the past Globalist Governor of California and other Officials of the State of California is a history of repeated injuries and usurpations, all having in direct object the establishment of an absolute Tyranny over the State of California.

Today California is in a state of free fall at all levels. This free fall has been orchestrated over the last 170 years by socialist and communist and we're now nearing the end of their socialist/communist plan that clearly demonstrates a design to reduce United States Citizens living in California under absolute Despotism. All their plans have been in direct violation of both Article IV, Section 4 and Article VI of the United States Constitution.
